Easy to Get Started

1. All you need is a blank cheque, write the word "VOID" across the front of the cheque, and attach it to the application.

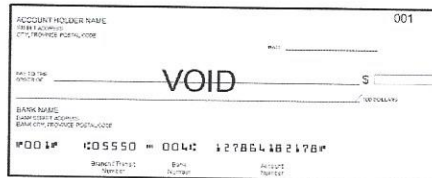

- I waive my right to receive pre-notification of the amount of the Pre-Authorized Payment and agree that I do not require advance notice of the amount of Pre-Authorized Payment before the debit is processed.
